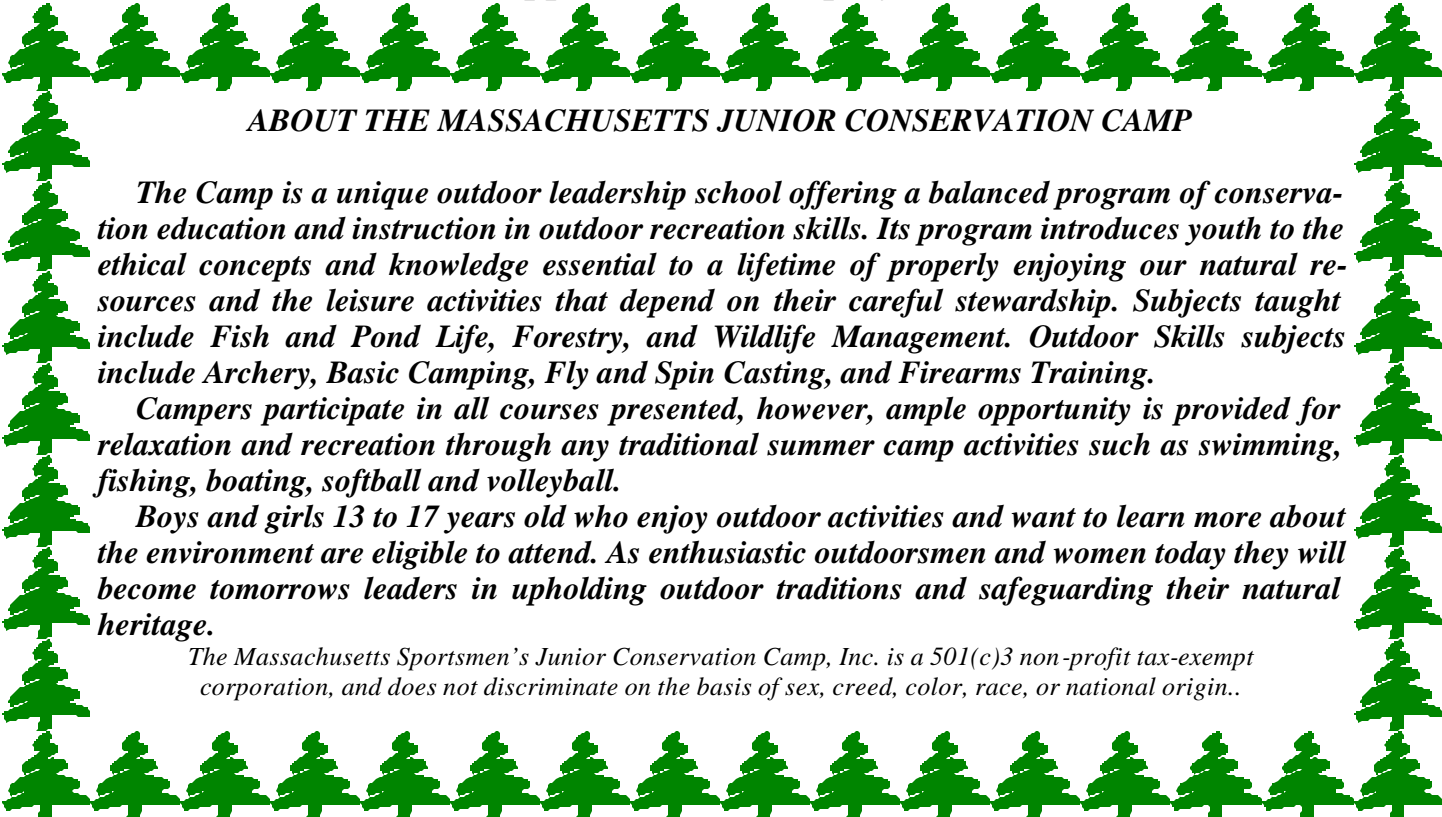

ABOUT THE MASSACHUSETTS JUNIOR CONSERVATION CAMP

The Camp is a unique outdoor leadership school offering a balanced program of conservation education and instruction in outdoor recreation skills. Its program introduces youth to the ethical concepts and knowledge essential to a lifetime of properly enjoying our natural resources and the leisure activities that depend on their careful stewardship. Subjects taught include Fish and Pond Life, Forestry, and Wildlife Management. Outdoor Skills subjects include Archery, Basic Camping, Fly and Spin Casting, and Firearms Training.

Campers participate in all courses presented, however, ample opportunity is provided for relaxation and recreation through any traditional summer camp activities such as swimming, fishing, boating, softball and volleyball.

Boys and girls 13 to 17 years old who enjoy outdoor activities and want to learn more about the environment are eligible to attend. As enthusiastic outdoorsmen and women today they will become tomorrows leaders in upholding outdoor traditions and safeguarding their natural heritage.
